WHAT DOES AMERICASH LOANS, LLC AND ITS AFFILIATES DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> ▪ Social Security number and income. ▪ Account balances, account activity and payment history. ▪ Credit history and credit score.
How?	All financial companies need to share customer personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer personal information; the reasons AmeriCash Loans, LLC and its affiliates chooses to share; and whether you can limit this sharing.

What we do

How does AmeriCash Loans, LLC and its affiliates protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does AmeriCash Loans, LLC and its affiliates collect my personal information?

We collect your personal information, for example, when you

- Open an account
- Provide employment information
- Apply for a loan
- Pay your bill with us
- Give us your contact information

We also collect your personal information from others, such as credit bureaus and affiliates.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- (i) AmeriCash Loans of Missouri, LLC
- (ii) AmeriCash Loans of South Carolina, LLC
- (iii) Short Term Financial, LLC

Non-affiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Non-Affiliates can include (without limitation) companies engaged in direct marketing and selling of consumer products and services.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- As allowed by law AmeriCash Loans, LLC and its affiliates may engage in joint marketing agreements to provide you with more financial products and services.

Other important information

Mail-in Form

Mark any/all you want to limit:

- Do not share personal information for our affiliates everyday business purposes (information about your credit worthiness) as permitted by law.
- Do not share personal information with affiliates for marketing purposes.
- Do not share personal information with non-affiliates for marketing purposes.
